## Attorney Charles E. Schmidt Jr. honored for distinguished service

On January 22, 2010, the Pennsylvania Association for Justice (PAJ) presented a Distinguished Service Award to **Charles E. Schmidt Jr.**, a partner at **Schmidt Kramer**, in recognition of Schmidt Kramer's 16-year sponsorship of the annual golf tournament benefitting United Cerebral Palsy (UCP) of Central Pennsylvania, as well as his personal dedication to the legal profession and PAJ. In announcing the award, PAJ president Kevin R. Marciano said Schmidt's long record of giving back to the community is a shining example of the caring, pro bono spirit of trial lawyers. Marciano said: "This award is about going beyond what's expected; therefore I am delighted to present this award to Chuck Schmidt for his extraordinary efforts on behalf of UCP of Central Pennsylvania and the trial bar."

The UCP/Schmidt Kramer Golf Tournament has raised nearly \$600,000 in 23 years, according to Janeen Latin, Director of Development for UCP of Central Pennsylvania. Schmidt Kramer's involvement with UCP goes back to 1993. While the money is important for funding UCP programs, Latin said it is Schmidt's "level of involvement" with the event and efforts on behalf of UCP that make the tournament so special. "Chuck epitomizes what it means to give back to your community both in terms of financial contributions and in terms of the importance of contributing time," Latin said. "He instills that in all of the employees at his firm, and that's very important to the most vulnerable populations in the community."

For Schmidt, who got involved with UCP because a friend's daughter has cerebral



palsy, his reward is knowing that his firm is able to make a difference. "We're successful because the entire firm participates, from staffing each green, to selling raffle tickets, to golfing," said Schmidt. The office is closed on the day of the tournament, he explained.

The 2009 tournament had over 120 golfers and made a profit of \$30,000. Schmidt Kramer also sponsors an "Attitude Essay Contest" open to area schools with the purpose of reducing attitudinal barriers between people with and without disabilities. The firm also contributes to other charities, including Toys for Tots and the Heart Walk.

A longtime member of PAJ's Board of Governors, Schmidt is an active volunteer and contributor to LAW PAC and has been an active member of the organization for decades. In 2012, his law partner, **Scott B. Cooper**, will become the second member of Chuck's firm to be president of PAJ. Schmidt said he is looking forward to that day and values his years of involvement with the association.

## QUESTIONS OF THE MONTH

**Q.** *What is the difference between SSR, SSD, and SSI?*

**A.** All of these initials are confusing. Social Security Retirement (SSR) is paid to you at retirement age based on the years that you worked. Social Security Disability (SSD) may be paid to you (1) if you apply and, if necessary, appeal; (2) you worked for approximately 10 years recently and have insured status; (3) you don't wait too long to apply after you stop working; and (4) you are disabled. Supplemental Security Income (SSI), like SSD, is payable to people who can't work, but only if the disabled person owns no property and has no source of income.

**Q.** *Can I receive both social security and workers' compensation?*

**A.** You can receive both SSR and WC, although your WC will be reduced unless you were already receiving it at the time you were injured at work. You can receive both SSD and WC, although your SSD will be reduced while you are receiving the WC. You can't get SSI and WC, because you will probably be over income.

**Q.** *What happens to my SSD if I settle my workers' compensation case?*

**A.** Your SSD will probably increase as long as your attorney puts special wording in your WC settlement papers prorating the lump-sum settlement over your expected lifetime. You may also need the permission of Medicare if you are closing the medical part of your workers' compensation case.

**Q.** *If I am receiving workers' compensation, I am automatically entitled to social security, right?*

**A.** Wrong. In order to get workers' compensation, you have to be hurt at work and be unable to do your job because of your injury. In order to receive SSI or SSD, you have to be unable to do any job, not just the job you were doing at the time you were hurt.

**Q.** *If I am receiving workers' compensation, why bother applying for SSD if I am going to only get a low amount?*

**A.** There are three good reasons to apply for SSD if you are receiving WC. First, SSD pays you the difference between your net WC and 80 percent of the income you were making at the time of your injury. Thus, if your WC is reduced because of the attorney fee in litigated cases, your SSD will go up and make up the difference. Also, there is no cost-of-living increase in WC cases, so if you have a serious injury, the SSD payment could be very important to you and your family. Second, SSD pays for dependent children. Third, you may be entitled to Medicare coverage.
