**Schmidt Kramer attorneys speak

## Question OF THE MONTH

**Q.** *Would you recommend I have full tort (right to sue) or limited tort (right to sue)?*

**A.** We recommend that every person who applies for motor vehicle insurance in Pennsylvania have full tort (right to sue) on their insurance policies. If you take limited tort, you save some money off of the full premium, but unless there is an exception, which in some cases is hard to establish, you give up the rights that you and anyone who resides in your household have to sue for pain and suffering if you are injured by another driver. This includes your spouse and children. In our years of experience, we have seen that it is more advantageous to have full tort instead of taking limited tort and saving some money.
