Question OF THE QUARTER OR WHAT DO YOU THINK?

Q. Will my insurance company fully reimburse me if my car is totaled in a car accident?

A. In most cases, you will probably be fully compensated. However, if you owe more for a loan or lease than the market value, then you need to make sure that you have what is called "GAP coverage" on your policy. If not, you may be responsible for anything over the market value because most traditional policies only reimburse you for coverage up to the market value. GAP coverage is relatively inexpensive and is important when the market value of your car is less than the amount of your loan or lease.

TOYS FOR TOTS

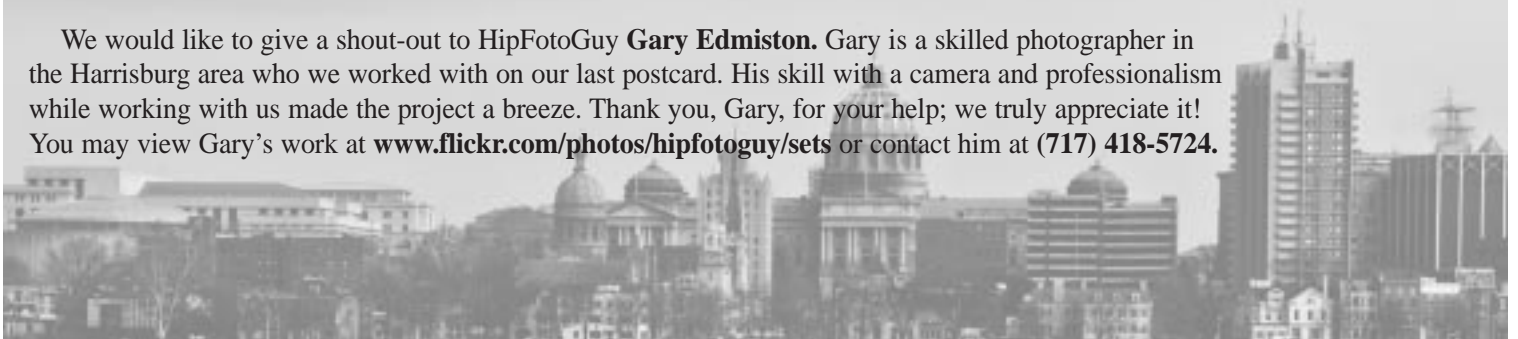
