## Sad news .....

## ATTENTION, PARENTS UNDERAGE DRINKING PARTIES

**Q:** *Can I serve my child alcohol at home?*

**A:** No. Under no circumstances does Pennsylvania law permit adults to provide minors with alcohol, even if parents are serving their children in their homes. The fine for providing alcohol to a minor is a mandatory minimum of \$1,000.

**Q:** *What penalties can underage drinkers face?*

**A:** The penalty for a first offense is a fine of up to \$300 and a driver's license suspension for 90 days. A 90-day jail sentence is also possible. Penalties for second and subsequent offenses can include license suspension for a year for a second offense, and two years for a third offense.

**Q:** *What steps can parents take to discourage underage drinking parties at home?*

**A:** Consider the following:

- ✓ Lock up all alcohol. Locksmiths can install locks for cabinets for less than \$100.
- ✓ Ask neighbors and family members to keep an eye on the house and on any children alone in the home.
- ✓ Know what your children will be up to, and verify as needed.
- ✓ Alert your police department to contact you if officers see suspicious activity at your home.


## The staff corner—
