

Question OF THE QUARTER

Q: Should the new limitations on joint and several liability move a person to change their auto insurance policy?

A: Yes. We see a much greater importance placed on uninsured motorist and underinsured motorist coverage. If two drivers cause an accident and a third person is injured, the injured person may not be able to recover his entire verdict even though a jury tries to compensate him. Having underinsured motorist coverage on your own car insurance policy will better prepare you to get back what you lost in a crash that is not your fault.
